



ASSUMPTION OF RISK & HOLD HARMLESS AGREEMENT

Oldcastle APG South, DBA Adams Products. ("Owner") agrees to allow the undersigned to enter upon property located at 2084 US Hwy 70 W, Goldsboro, NC 27530 ("Property") for an event on **March 21, 2025**. In exchange for being allowed to enter the Property, the undersigned agrees to assume all risk and responsibility for and to defend, indemnify, and hold Owner, its insurers, affiliated companies, officers, and employees, harmless from any injury or damages sustained by the undersigned which results from or relates to the undersigned's presence or activities on the Property. I understand that Owner is engaged in the construction industry and that there are certain hazards associated with the construction industry, including the operation of construction equipment.

I understand that Owner and its personnel cannot advise me of all the risks associated with the Property and agree that I am not in any way relying on Owner or any of its personnel to protect me or advise me of all possible safety hazards. I agree, therefore, to be responsible for my own safety and acknowledge that I accept the risks associated with Property and the activities taking place on the Property. Further, I agree to stop any activity which appears to be unsafe and immediately advise the event organizers of that safety issue.

The undersigned agrees to obey all laws and regulations while on the Property, including Owner's safety policies. Further, the undersigned authorizes the Owner and its agents to obtain photographic or other electronic recordings of the undersigned while the undersigned is on the Property. Owner is authorized to use those electronic recordings in the future without any payment to the undersigned.

If any provision of this Agreement is held by any court to be unenforceable, then that unenforceable provision shall be severed from this Agreement and the remaining portions shall remain in full force and effect.

I ACKNOWLEDGE THAT I HAVE READ THIS AGREEMENT, UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AM SIGNING IT FREELY AND VOLUNTARILY IN EXCHANGE FOR THE CONSIDERATION SET FORTH HEREIN WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTY BEING MADE TO ME, AND THAT I INTEND BY MY SIGNATURE FOR THIS AGREEMENT TO EFFECT A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
